



Pathway for the 2020 Olympic Games

The following pathway is what Boxing Canada plans to implement to select athletes to compete at Olympic qualifying events in 2019 and 2020. This information is subject to change and will be updated after the 2020 Olympic Qualification Guidelines are published.

2019 Olympic Qualification Pathway

The following process summarizes the pathway and the events that will be utilized by Boxing Canada to select athletes to compete in Olympic qualifying events that are anticipated to take place in 2019.

Athletes Eligible

- High Performance Program Athletes (<https://boxingcanada.org/documents/>)

Once selected to the High Performance Program, athletes will be eligible for opportunities to participate in training camps and international competitions. The selection of athletes to compete at the anticipated 2019 Olympic qualifying events will be based on the specific selection criteria available on Boxing's Canada website (<https://boxingcanada.org/documents/>).

2019 Olympic Qualifying Events:

As of April 2019, Boxing Canada expects the following competitions to be Olympic qualifying events in 2019:

- 2019 AIBA Elite Men's World Championships (September 7-21, 2019 – Yekaterinburg, Russia)
- 2019 AIBA Elite Women's World Championships (October 3-11 - October 2019 – Ulan Ude, Russia)
- 2019/2020 World Series of Boxing Season IV – Elite Men (TBD – October 2019 – February 2020)

If Canada qualifies an athlete for the 2020 Olympic Games, by name, through the 2019 AIBA Elite Men's World Championships or the 2019 AIBA Elite Women's World Championships, this weight category will be competed at 2020 Men's and Women's Canadian Trial for the purposes of naming an athlete to the anticipated Olympic qualifying events in 2020 should the athlete who earned the Olympic nomination in 2019 be unable to participate in the 2020 Tokyo Olympic Games for whatever reason.

Following the completion of the 2019 AIBA Elite Men's World Championships and 2019 AIBA Elite Women's World Championships, any weight category that Canada has not qualified will be

disputed at the 2020 Men's and Women's Canadian Trial, as outlined below, to determine athlete selection for 2020 Olympic qualifying events.

2020 Olympic Qualification Pathway

The following process summarizes the pathway and the events that will be utilized by Boxing Canada to select athletes to compete in Olympic qualifying events that are anticipated to take place in 2020.

Athletes Eligible

- 2020 Men's and Women's Canadian Trial Champion

The 2020 Men's and Women's Canadian Trial (TBD, January 2020) will be eligible for opportunities to participate in training camps and international competitions. The selection of athletes to compete at the anticipated 2020 Olympic qualifying events will be based on the specific selection criteria available on Boxing Canada website (<https://boxingcanada.org/documents/>)

The following summarizes the 2020 Men's and Women's Canadian Trial Guidelines, as well as the selection process that will be utilized by Boxing Canada to select athletes to compete in the 2020 Men's and Women's Canadian Trial.

The 2020 Men's and Women's Canadian Trial – Boxing Weight Categories

2020 Men's and Women's Canadian Trial Eligible Athletes:

- High Performance Program Athletes competing in an Olympic Division
- One (1) athlete per Provincial Association per weight category

If Canada qualifies an athlete for the 2020 Olympic Games, by name, through the 2019 AIBA Elite Men's World Championships or the 2019 AIBA Elite Women's World Championships, this weight category will be competed at 2020 Men's and Women's Canadian Trial for the purposes of naming an athlete to the anticipated Olympic qualifying events in 2020 should the athlete who earned the Olympic nomination in 2019 be unable to participate in the 2020 Tokyo Olympic Games for whatever reason.

2020 Olympic Qualifying Events:

As of April 2019, Boxing Canada expects the following competitions to be Olympic qualifying events in 2020:

- 2020 AMBC Elite Men's & Women's Continental Olympic Qualifier (TBD - 2020)
- 2020 AIBA Elite Men's Final World Qualifier (TBD - 2020)
