BOXING CANADA

HALL OF FAME – NOMINATION PROCEDURES

Purpose

To formally recognize the achievements of those Boxers, both Male and Female who have achieved exceptional results throughout their boxing careers, both at the National level and the International level.

To formally recognize the dedication, leadership and abilities of those individuals who have made an outstanding contribution to the development of Boxing in Canada.

Therefore, there will be two (2) categories of membership in the Boxing Canada Hall of Fame: **Athlete** and **Builder**.

Acknowledgement

The Boxing Canada Hall of Fame shall be located within the National Office, where an acknowledgement of the achievements of the inductees shall be kept for public viewing.

A special section on Boxing Canada's website will also display the inductees' profiles and accomplishments.

The provincial boxing association of the inductee shall receive a duplicate of the citation of achievements.

Selection Committee

Members shall be appointed because of their knowledge in the history, tradition and skills of boxing and whose prestige, judgement and integrity are most likely to ensure the fair and impartial assessment of the qualities of the candidates submitted.

Appointments of the Committee shall be made with the object of securing maximum continuity of composition of the Committee.

The Boxing Canada Board of Directors shall appoint a Chairman of the Selection Committee who reports directly to the Executive Director

The Selection Committee shall consist of at least two members of Boxing Canada Hall of Fame and the Chair. The Executive Director of Boxing Canada shall be an ex-officio member and the secretary of the Committee.

Induction

Members will be formally inducted into the Hall of Fame, the place and time to be determined by the Executive Director. In absence of a special event, the induction may take place during a National or Provincial Championships.

Nomination procedures

- Nominations shall be made in writing and must be filed with the Executive Director c/o
 the Boxing Canada Office by January 31 of each year. Nomination documents must
 include:
 - Nomination Form Appendix A
 - Eligibility Form (Athlete or Builder) Appendix B or C
 - A 5"x7" photograph of the person being nominated

- Optional citation covering other Boxing accomplishments and/or the service record, or both, of the person nominated can be included for information only.
- 2. The nominator should ensure that the nominee meets the Eligibility Criteria described in this document.
- 3. Nominations may originate from an individual (no self-nomination), club, association, or by a member of the Selection Committee (hereafter called the Committee).
- 4. The Executive Director shall send out to each member of the Committee, a copy of each nomination and recommendation received and all supporting material, together with the names of their respective nominators. This shall be done following the close of nominations.
- 5. The Committee shall review the nominations and present a list of recommended candidates to be vetted by the Executive Director of Boxing Canada.
- 6. Inductees shall be announced following Board approval at the Annual General Meeting of Boxing Canada.
- 7. Hall of Fame inductees will automatically become Boxing Canada Life Members.
- 8. If the Chair of the Committee is not a member of the Hall of Fame, he/she will not be eligible for nomination while on the Committee and for a period of one year after leaving the Committee.
- 9. The Committee shall have the responsibility to ensure the integrity and quality of the Hall of Fame is maintained. The number of members inducted in any one year shall be at the sole discretion of the Committee. The Committee shall not be obligated to admit anyone in any given year.

Removal

An inductee into the Boxing Canada Hall of Fame may be expelled from it on any or more of the following grounds:

- Contravention of the Boxing Canada Constitution or any rules made hereunder;
- Conduct contrary to the ethics of Olympic boxing and Boxing Canada;
- Conviction for commission of an indictable offence under Federal or Provincial law

The procedure to expel the inductee shall be the procedure for expulsion of a member of the Association as set out in the Constitution of the Association.

BOXING CANADA HALL OF FAME – NOMINATION PROCEDURES

ATHLETE'S CATEGORY

Purpose

To formally recognize the achievements of those Boxers, both Male and Female who have achieved exceptional results throughout their boxing careers, both at the National level and the International level. One of the following criteria must be met to be eligible for nomination to Boxing Canada's Hall of Fame.

Criteria

Criteria 1

• The athlete who has won a gold medal at the Olympic Games or Elite World Championships automatically qualifies as a potential nominee.

Criteria 2

- The athlete has attended either of the following International competitions representing Canada:
 - o Olympic Games
 - Elite World Championships

OR

The athlete has won a gold medal at the youth world championships.

OR

- The athlete has achieved exceptional success in Canada during our National Championships over a period of not less than (five) years.
- Along with one or more of the above criteria listed in our second category, the athlete must have won a medal at one of the following major games:
 - o Pan Am Games
 - o Commonwealth Games
 - Francophone Games

Candidates shall normally not be considered until after a four (4) year waiting period following retirement from national and major international competition. However, on exceptional basis, the committee may decide to accept nomination earlier or before their official retirement.

BOXING CANADA HALL OF FAME – NOMINATION PROCEDURES

BUILDER'S CATEGORY

Purpose

To formally recognize the contribution, leadership and abilities of those individuals who participate in the development of Boxing.

Coaches Criteria

- Must have participated in the development of boxers who represented Canada at the Olympic Games or the Elite World Championships, or who won a medal at two of the following: Pan American Games, Commonwealth Games or Francophone Games.
- Must have coached at least ten (10) years, not necessarily consecutively
- Other contributions such as clinics, video, films, books and training manuals will be considered, but are of secondary importance.

Officials Criteria

- Must have officiated at the National (Elite, Youth or Junior) Championships on at least five (5) occasions.
- Must have officiated at least ten (10) years, not necessarily consecutively
- Must have officiated at either of the following Major Games; Olympic Games, World Championships, Pan American Games, Commonwealth Games, Francophone Games
- Other contributions such as clinics, video, films, books and training manuals will be considered, but are of secondary importance.
- Must be retired from competition for at least one (1) year following his/her official
 departure from officiating. However, on exceptional basis, the committee may decide to
 accept nomination earlier or before their official retirement.

Administrators / Builder Criteria

- Must have served as an administrator for at least ten (10) years, not necessarily consecutive.
- Must have served on a National committee for at least four (4) years.
- Must have served for several years on committees for National, Continental or International bodies.
- Must have been instrumental in the development of the sport in exceptional ways whether internationally, nationally, provincially, locally, financially, fund-raising, volunteer etc.
